	SuiteAnalytics Enhancements > Transaction Links to the previous and next transaction, Primary accounting book filter when using Multi-Book, Transaction Overview pivot table, Account Turnover pivot table
	Budgets for Customers' Secondary Subsidiaries > create a budget for any of the customers' assigned secondary subsidiaries
Advanced Revenue Management	Revenue Arrangement Summary Subtab > New subtab on the revenue arrangement shows a summary of the quantity, discounted sales amount, revenue amount, amount recognized, carve in/out amount, and amount billed for each revenue element.
	Linked Elements > updated functionality allows for the linking of revenue elements for associated positive sales transactions. Previously, it was only possible to link negative return elements with the associated positive sales elements.
	Enhanced Revenue Allocation Support for SuiteBilling Change Orders > A new accounting preference allows for the ability to choose whether or not to use a retrospective or prospective merge when combining revenue arrangements for subscriptions.
Administration	Depreciation Plan for the Full Access Role > has been deprecated since 2019.1 and is targeted to be disabled as of 2021.1, January 2020 – the role will be set to inactive
	See Differences in Employee Access Permissions on the Role Permissions Differences Page > see differences in Employee Access permissions and restrictions between different roles, category called Employee Access
	File Cabinet > new default for hide attachments folder preference embedded antivirus scanner automatically scans all new and updated files
	Internationalization > support for record localization context, ability to filter script execution according to localization context, tailor scripts for certain countries. Supported records – Item, Transaction, Entity
	Subsidiary Hierarchy Modification > can now modify subsidiary hierarchy structure
	Automated Intercompany Management Preference Relocated > no longer on Item/Transactions subtab on the Accounting Preferences page now located under Setup > Accounting > Preferences > Intercompany Preferences
	Deprecation of Google OpenID SSO and NetSuite Inbound SSO Features > OpenID Connect SSO and SAML SSO are the suggested alternatives for inbound SSO access
	Cloud Infrastructure > Data Center-Specific NetSuite Domains for Integrations are Targeted for Depreciation
Banking	Bank Feeds > can set up bank feeds directly from financial institution accounts, enabled monitoring and managing cash flow needs with better accuracy and predictability, supported for United States and Canada, automatically import bank data and account balances on a daily basis, receive daily updated cash balances
	Financial Institution Connectivity API > replaces the Bank Connectivity API, which is deprecated as of 2020.1

	Bank Data Matching Improvements > can now review and exclude imported bank data from the matching process on the To Be Matched subtab, Banks feeds with a manual update function automatically updates bank data each day, Unmatched subtab is renamed To Be Matches, Review Matches subtab is renamed Matches to Submit
Employee Management	Manager Self-Service Enhancements for Employee Change Requests > guidelines and relevant links, salary and job duration insights
	CSV Import for Effective Dating > perform bulk updates to the employee record as of a past, current, or future date
	Advanced Employee Permissions – Customizable Restrictions > restrict the instances that a role has access to the employee record by location and subsidiary Exclusion of Lists > Employee Permissions will take precedence over any of the employee permissions included
	Bonuses in Compensation Tracking > create multiple bonus types, track bonus targets and bonus awards, can pay if using SuitePeople U.S. Payroll
	Expense Account Override > can select an expense account for individual expense item on an expense report, Category field is no longer required
	Time Modification Enhancements > update unbilled or non-posted time entries with generated charges, only time entries you have permission to edit appear in list, bulk edit all time entries submitted for assigned projects, time modification request record available to use with workbooks, Override Rates on Time Records preference allowing seeing the Rate and Price Level field
